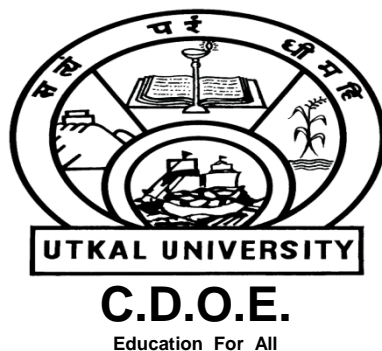
### **ABOUT THE UNIVERSITY**

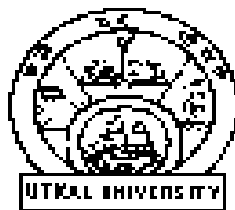

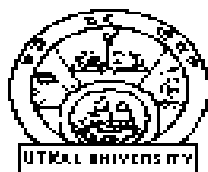
