I. Overview

ABOUT UTKAL UNIVERSITY

The Utkal University founded on 27.11.1943 is the mother University of Odisha. Dr.Rajendra Prasad, the first President of India, laid down the foundation of the present 400-acre sprawling campus on 1st January 1958. Several Post-Graduate Departments and other Centres were established in the University Campus. There are more than three hundred general affiliated colleges under the University. The Centre for Distance and Online Education (CDOE) a constituent directorate of the Utkal University, had a modest beginning as the University Evening College in October, 1962 with an objective to provide continuing education. On 27th November, 1974, The University Evening College was converted into Directorate of Correspondence Courses. As per the revised UGC guidelines for Open and Distance Learning, the DCC was converted to Directorate of Distance and Continuing Education (DDCE) w.e.f. 15.10.1996. As per the DEB-ODL guideline the name of DDCE was renamed as Centre for Distance and Online Education (CDOE) w.e.f. June 2023.

Course Curriculum:

The curriculum of the B.A Political Science program is prepared by the Board of Studies (BoS) of each discipline by Utkal University. The Model CBCS Syllabus for B.A Political Science is prepared by the Dept. of Higher education, Govt. of Odisha. During the process of framing the curricula, inputs from eminent academicians and industry professionals are also accommodated. The activity of curriculum design is carried out from time to time, updated whenever felt necessary. The curricula prepared by the BOSs are then placed before the Academic Council of the University for Necessary Approval. Institution adopts a specialized approach where the task involved in course design & development is assigned to professionals in the particular department of the university and/or external experts. The B.A Political Science program was approved by the Academic Council in its meeting held on 29.04.2000. At present the CBCS structure is adopted in the B.A Political Science course Curriculum.

Contact Programme:

There will be a contact program for a minimum duration of 15 to 20 days normally. A minimum of 18 Hours of sessions of classes are conducted per paper per semester. The contact classes are conducted by scholarly faculties. The counseling sessions are mainly based on interaction built around lectures, discussions, question-answer sessions, etc.

Student Support Service:

The Students can interact with the Office/Faculty through e-mails personal visits, and WhatsApp groups. SMS alert facility is also adopted by the students regarding dissemination

of information relating to the conduct of PCPs/Orientation Programme/ conduct of examination/ publication of results and Production file submission deadlines etc. All notices and detailed information are uploaded to the website (www.ddceutkal.ac.in). Student Support Service is provided through online mode and a grievance handling mechanism is adopted with the help of supporting technical staff. Internal Assignments with Guidelines, previous years' question papers, notifications timetables, and results, and Project guidelines are available from the website. The payment links are also supplied to the students where students can pay the fees online through the payment gateway. Students can upload their documents to the respective portal directly.

(vi) Procedure for admissions, curriculum transaction and evaluation:

Process of Admission

- The eligibility for taking admission into to B.A in Political Science (Hons.) course is +2 or an equivalent course. Students who have passed Three Year Diploma from Orissa State Technical Education Council are also eligible.
- The students apply online on the website (www.ddceutkal.ac.in).
- After filling up the form the applicant has to upload all the required documents, recent photo and signature in the portal.
- After verification of the application form and documents, an email communicated to the candidates to pay the course fees.
- The admission fees and other fees are paid by the candidate through the payment gateway.
- After the completion of the admission the student can download e-identity card syllabus and study materials from the website.

Examination:

CDOE is an institution owned and controlled by the authority of Utkal University. The examination in respect of CDOE students is conducted by Utkal University. All matters relating to the examinations, i.e. result mark sheet, degree, etc. are dealt with by the Controller of the examination, Utkal university.

Evaluation:

The empaneled question setters set the university examination questions. The empaneled evaluators also evaluate the Summative assessment (end semester examination) answer script (80 marks). The Continuous or formative assessment (in semester) is also conducted through written examination, submission of Assignments evaluations of Assignments / Seminars/class tests/tutorials, etc. which are also evaluated by the approved evaluators (20 marks).

(vii) Requirement of the laboratory support and Library Resources:

Laboratory hours are not mandatory for B.A Political science, but students can avail the computers in the LAB, which is available inside the CDOE, Campus. With high speed internet connection and wifi facility.

The CDOE has its own Library, having 18479 books. Except that the students of CDOE, can access the Parija Library (Central Library) at university campus.

M. CONTACT PROGRAMME:

There will be a contact program for a minimum duration of 15 to 20 days normally. A minimum of 18 Hours of sessions of classes are conducted per paper per semester. The contact classes are conducted by scholarly faculties. The counseling sessions are mainly based on interaction built around lectures, discussions, question-answer sessions, etc.

N. STUDENT SUPPORT SERVICE:

The Students can interact with the Office/Faculty through e-mails personal visits, and WhatsApp groups. SMS alert facility is also adopted by the students regarding dissemination of information relating to the conduct of PCPs/Orientation Programme/ conduct of examination/ publication of results and Production file submission deadlines etc. All notices and detailed information are uploaded to the website (www.ddceutkal.ac.in). Student Support Service is provided through online mode and a grievance handling mechanism is adopted with the help of supporting technical staff. Internal Assignments with Guidelines, previous years' question papers, notifications timetables, and results, and Project guidelines are available from the website. The payment links are also supplied to the students where students can pay the fees online through the payment gateway. Students can upload their documents to the respective portal directly.

O. REQUIREMENT OF THE LABORATORY SUPPORT AND LIBRARY RESOURCES:

The program requires the usage of computers and the Internet which are also made available at the Centre. CDOE is also equipped with a library, to support the program. The students have access to online material and can access the same anytime and anywhere for their learning purposes. The e-learning resources are also available on the website which can be accessed by the students. The recorded lecture session is also circulated in the student's group. Each student gets the study matters during admission and readmission.

P. EXAMINATION:

CDOE is an institution owned and controlled by the authority of Utkal University. The examination in respect of CDOE students is conducted by Utkal University. All matters relating to the examinations, i.e. result mark sheet, degree, etc. are dealt with by the Controller of the examination.

I. Overview

ABOUT UTKAL UNIVERSITY

The Utkal University founded on 27.11.1943 is the mother University of Odisha. Dr. Rajendra Prasad, the first President of India, laid down the foundation of the present 400-acre sprawling campus on 1st January 1958. Several Post-Graduate Departments and other Centres were established in the University Campus. There are more than three hundred general affiliated colleges under the University. The University has 15 Autonomous Colleges under its jurisdiction. It has twenty-seven Post-Graduate Departments, two Constituent Law Colleges, and a Centre for Distance and Online Education (CDOE) The University also offers several Self Financing Courses.

Utkal University is recognized by the UGC. It is a member of the Indian Association of Universities and the Commonwealth Association of Universities. Utkal University has been reaccredited by NAAC with an A+ Grade in December 2023 for five years. Utkal University is also placed amongst the top100 universities of India as per the ranking of NIRF for the last 4 years consecutively (2023-93th rank, 2022-88th rank, 2021-87th rank & 2020-96th rank)

ABOUT CENTRE FOR DISTANCE AND ONLINE EDUCATION (CDOE):

The Centre for Distance and Online Education (CDOE) a constituent directorate of the Utkal University, had a modest beginning as the University Evening College in October, 1962 with an objective to provide continuing education. On 27th November, 1974, The University Evening College was converted into Directorate of Correspondence Courses. As per the revised UGC guidelines for Open and Distance Learning, the DCC was converted to Directorate of Distance and Continuing Education (DDCE) w.e.f. 15.10.1996. As per the DEB-ODL guideline the name of DDCE was renamed as Centre for Distance and Online Education (CDOE) w.e.f. June 2023.

II. Programme's Mission & Objectives

(i) Mission:

To impart effective, supportive, accessible and affordable knowledge, and skills in education through both Open and Distance Learning (ODL) & Online (OL) Programmes made to the students and working professionals to help them develop teaching and research skills to enhance their career

- To impart skill and knowledge base in arts students to equip them for career in arts, culture, history, development administration and policy making etc.
- To offer education to policy makers, corporate citizens, socio-political activist and others to enable them to understand the society, culture, polity, education and to enhance their professional competency.

III. Relevance of the programme with HEI's Mission and Goals:

University Mission

In order to align with the mission and goals of Utkal University, the ODL/OL mode B.A Education (Hons.) is planned to enable students and working professionals gain knowledge in various domains of education and research, specialize in a domain of their choice, gain knowledge of not only the skill of teaching but also on skill like critical thinking, teaching strategies, classroom management, leadership and decision making.

5. To provide required theoretical and practical quality education with necessary infrastructure & facilities to the unreached from far flung places.
6. To develop creative thinking by delivering relevant required inputs to make them experts and professionals in the field.
7. To provide opportunity to all eligible and enthusiastic persons who couldn't pursue their higher education in more economical way.
8. To help in fulfilling the current requirement of society, government and others.
9. To create a conducive learning environment.
10. To provide flexible, technology driven and cost-effective educational delivery system to meet the current requirements of the society.

IV. Nature of Prospective target group of learners:

For the programme, the students have successfully completed Higher Secondary level from any recognized board. They are considered as the target group of learners for the programme. In Odisha, a lot of Learners pass higher secondary (10+2) examination. But due to limitation of seats in the conventional Universities/ colleges in Education (Honours), all of them could not get enrolled themselves in the subject of their choice (i.e., Education). In recent years there are ample scope of higher studies as well as research in Education, thus the Learners opt this subject by choice. Besides, target group of learners are a person from different age groups who wishes to pursue higher education and enhance their knowledge in the discipline to seek for a better career and lead a responsible life. The learners are from different socio-economic background and are located in different parts of the state. In compliance with the ultimate objective of distance education to reach the unreached, special care is taken to include learners from marginalised sections of the society, backward caste and tribes. This makes for a very heterogeneous learner group.

However, the prospective target group of learners may be:

1. Fresher's as well as in-service learners
2. From both urban as well as rural areas
3. From background of rich, middle and poor section of the society

V. Appropriateness of programme to be conducted in Open and Distance Learning mode to acquire specific skills and competence:

The launching of B.A Education Hons. Programme through open and distance learning mode shall be befitting for those: 1. Who are deprived of getting a seat in regular mode, 2. Who are employed/ self-employed but not getting time to attend classes regularly. They are unable to go to regular classes. Additionally, they wish to raise their academic standards in order to advance their careers. Those with a +2 who work in primary or elementary schools desire to advance their education for their careers. Many of them are young people without jobs. They aim to advance their academic careers to increase their chances of finding employment. The majority of the students are females and young girls. Because of various factors, they were unable to enrol themselves. Education is one of their elective subjects. They will gain something from this course as well.

The courses in the programme are delivered through both ODL/OL mode which is a modular unit of e-learning material which is inter-alia self-explanatory, self-contained, self- directed at the learner, and amenable to self-evaluation, and enables the learner to acquire the prescribed level of learning in a course of study and includes contents in the form of a combination of the following e-Learning content, and made available through four-quadrant approach namely,

1. e-Tutorial - faculty led Audio - Video Lectures
2. e-Content (combination of PDF/ epub) Text Materials,
3. Discussion forum for raising of doubts and clarifying the same on real time basis by the Course Coordinators/Course Mentors assigned to students
4. Self- Assessment Quiz, Test and Assignments to reinforce learning. Reference books are also mentioned in the syllabus. Latest Edition of Reference books may be referred to.

VI. Instructional Design

Course Curriculum: Institution shall adopt specialized approach where the task involved in course design & development is assigned to professionals in the particular department of the university and/or external experts. A draft with the objectives shall be prepared. It shall be evaluated by Institution who in turn composes a team of experts to have judicious review of the proposed course that it meets the objectives of ODL/OL education.

Program Structure: Institution shall constitute a team of experts to review the course structure. The review team shall provide its feedback and recommendations to the concerned faculty. In case of any modifications suggested by the review team, the curriculum of the course shall be re-worked upon.

Study Materials: The study material shall be Self-Learning (SLM) format, which is the essence of standard distance learning Programs. Thus, Institution shall initiate to develop all materials in SLM format. Experts both internal & external shall write the study materials in papers like educational

psychology, research methods, measurement and evaluation, guidance and counselling etc. on the specific guidelines laid down by the statutory body.

Review by Board of Studies (BOS): The course shall meticulously be reviewed by BOS. Recommendations of BOS shall be implemented on priority. It shall also check & define the applicability, credit hours, scheme of examinations for the course.

Approval by Academic Council: Finally, the course shall be submitted to the Academic Council of the University for Final Approval.

Programs shall be offered on semester basis. A modular approach towards pursuing a long-term degree Program shall be implemented. Academic activities shall be linked together to engage learner and maximize learning.

VII. Procedure for admissions, curriculum transaction, evaluation and medium of instruction:

Admissions are conducted through Online and Offline mode.

Selection process

Documents required for admission

- Caste certificate for SC & ST candidates.
- Each candidate is required to carry a photo identity card (Aadhar Card/Driving license / PAN Card / Voter's I Card or Identity card issued by employer / educational institute etc.) for the online test for Management and Computer Science Programme.

Transaction of Curriculum

The whole curriculum of the programme is well structured and well designed with the updated syllabus structure. The curriculum transaction involves the face to face/online PCP sessions through chalk and talk method, use of Power Point presentations, web-based lessons, animated videos, etc. The PCP sessions would be such that the learner should participate actively in the discussion. Apart from this ICT enables online supports are provided for better understanding of the subject. Practical classes are also taken through face to face mode for better understanding of the subject. Curriculum transaction is through Online and or Offline modes as detailed above
