1. No application shall be entertained unless it is properly filled in all columns and submitted alongwith necessary documents in conformity with the Regulations and instructions of the University.
2. No candidate shall be allowed to offer any course unit subject or paper other than those mentioned in this application provided the candidate is eligible under the Regulations to offer such Subject or Paper.
3. No application for admission to the examination shall be entertained after the due date. In exceptional cases permission may be granted provided the reasons for the delay were considered to the sufficient and such application along with the requisite fee reached the office within seven/ fifteen days after the due date with a late fee of Rs. 20/ 50/ 200 respectively.
4. The certificate shall be signed in case of the regular candidates sent up by a College / Department by the Principal of the College/ Head of the Department.
5. FEES PAYABLE : As per notification.

The Head of Institution shall forward fees in a consolidated Bank Draft made payable to the Comptroller of Finance, Utkal University at Utkal University Campus Branch of State Bank of India or remit the same in the State Bank of India, Utkal University Campus Branch in the Utkal University General Fund Account-IV.
